## LIMITED WARRANTY

*THIS LIMITED WARRANTY IS EXTENDED TO THE ORIGINAL RETAIL PURCHASER OF A TWILIGHT SPA:*

**FUSION AUDIO SYSTEM:** Master Spas warrants to the original retail purchaser, the optional stereo and enclosure components of the audio system to be free of defects in material and workmanship for a period of one (1) year. This limited warranty on all optional Audio Equipment covers labor for a period of (90 days) from the date of original retail purchase. After (90 days) the purchaser is solely responsible for any labor costs associated with the repair or replacement of a defective component. Master Spas shall not be responsible for any damages or losses to any accessories, including but not limited to iPods or similar systems, caused by a defect or malfunction of any component (parts and labor).

**CD/STEREO:** Master Spas warrants to the original retail purchaser, the optional Audio/Video Equipment (TV, DVD, Speakers, Subwoofer and Lift System) against malfunction due to defects in material and workmanship for a period of one (1) year from the date of original retail purchase. The stereo and enclosure components of the audio system are warranted to be free from defects in material and workmanship for a period of (3) years. This limited warranty on all optional Audio Equipment covers labor for a period of one (1) year from the date of original retail purchase. After one (1) year purchaser is solely responsible for any labor costs associated with the repair or replacement of a defective component. Any and all remotes are excluded and not warranted by Master Spas. Master Spas shall not be responsible for any damages or losses to any accessories, including but not limited to iPods or similar systems, caused by a defect or malfunction of any component (parts and labor).

**STRUCTURAL INTEGRITY AND SURFACE FINISH:** The acrylic surface finish is warranted not to blister, crack or delaminate due to defects in material and workmanship for a period of five (5) years from the date of original purchase. If a warrantable defect occurs, the spa shell will be repaired or replaced at the option of Master Spas, Inc. The cost of shipping and installing a replacement shell is the sole responsibility of purchaser (repair or replacement).

**PLUMBING AND EQUIPMENT PACK:** The plumbing of the Twilight spa is warranted to the original retail purchaser to remain free from leaks due to defects in material and workmanship for a period of three (3) years from the date of original retail purchase. The equipment pack (pumps, heater, and control system) are warranted against malfunction, due to defects in material and workmanship to the original retail purchaser for a period of three (3) years from the date of original retail purchase. If a warrantable defect occurs, the defective item will be repaired or replaced at the option of Master Spas, Inc. (parts and labor). Jet internals are warranted to be free of defects in material and workmanship for a period of three (3) years from the date of original purchase (parts only).

**SKIRTING:** Master Spas, Inc. warrants to the original retail purchaser that the MasterSelect™ and Dreamstone™ skirting will not crack or rip due to defects in material for a period of five (5) years from the date of the original retail purchase. Master Spas, Inc. warrants to the original retail purchaser that the DuraMaster Polymer™ skirting, will not crack or rip for the life of the spa. This limited warranty applies only to the original retail purchaser. The cost of shipping and installation of any replacement skirting is the sole responsibility of purchaser (parts only).

**(Optional) LED LIGHT SYSTEM:** The LED light system is warranted to the original retail purchaser (if supplied) for a period of two (2) years from the original retail purchase to be free of from defects in workmanship and materials. This limited warranty on all optional LED light systems covers labor for a period of one (1) year from the date of original retail purchase. After one (1) year the purchaser is solely responsible for any labor costs associated with the repair or replacement of a defective component.

**OZONATORS:** Master Spas, Inc. warrants to the original retail purchaser that the factory installed Ozonators will not malfunction due to defects in the Ozonator for a period of two (2) years from the date of original purchase (parts and labor).

**LIMITATIONS:** This limited warranty applies to portable spas manufactured by Master Spas, Inc. and sold by a Twilight Spas dealer to residential retail customers only. This limited warranty is void if the Twilight spa is used for commercial purposes. This limited warranty is extended only to the original retail purchaser. This limited warranty becomes void upon the transfer of ownership of the spa or moving of the spa to a different location. Light bulbs, light lenses, fuses, covers, spa pillows or any dealer installed accessories are specifically excluded from this limited warranty. Cost of installation, removal and/or shipping of the spa or replacement parts are not covered by this limited warranty and are the sole responsibility of the purchaser. In the event it is necessary to remove the spa to perform a covered repair, or if the spa must be replaced, any and all costs of spa removal and replacement, including but not limited to shipping, labor, landscaping, decking, fencing or other costs associated with the removal and replacement of the spa are the sole responsibility of the purchaser. When attempting to inspect, repair or replace if it is necessary to incur cost to obtain access to the spa, any such costs to obtain access shall be the sole responsibility of the purchaser. Master Spas, Inc. reserves the rights to void the equipment warranty should any damages occur to the system from the use of filter cartridges other than those approved by Master Spas, Inc. Master Spas, Inc. in its sole discretion shall determine if any damage to equipment is the result of the use of an unapproved filter.

**EXCLUSIONS:** This limited warranty specifically excludes defects or malfunctions if it is determined that the spa has been subject to misuse, alteration or attempted alteration, repairs or attempted repairs by a non-authorized representative of Master Spas, Inc., improper installation, improper water chemistry, improper maintenance, an act of God or other damage from causes beyond the control of Master Spas, Inc. during the manufacturing process. In addition, this limited warranty is void if the owner has operated the spa other than in conformity with the Twilight Spas owner manual, such as but not limited to: leaving the spa uncovered while the spa is empty, covering the spa with plastic film of any kind, use of unapproved cleaners or solvents, operation of the spa at water temperatures outside the range of 34°F - 104°F, the use of unapproved sanitizers, failure to maintain proper water chemistry, operation of the spa outside specified voltage requirements (230v ± 10%) or any other improper use. Any damage caused by freezing is specifically excluded from this limited warranty.

**WARRANTY REGISTRATION AND CLAIMS:** The original retail purchaser must send in a completed warranty registration card to Master Spas, Inc. or register on line at [www.masterspas.com](http://www.masterspas.com) within ten (10) days of the date of original installation. In the event of a warranty claim of a defect or malfunction covered under the provisions of this limited warranty, the original retail purchaser must notify the retail dealer in writing who sold the spa or Master Spas within ten (10) days of the malfunction. Upon notice of a warranty claim, the dealer, or an authorized representative of Master Spas will inspect the spa in a reasonable time after the initial notification to determine if the malfunction or failure is a covered malfunction or defect under this limited warranty. If a service call is fielded and determined by the dealer to be a non-warranty service call, the cost of the service call is the sole responsibility of the purchaser. If it is determined that the malfunction or defect is covered under this limited warranty, Master Spas through its dealer or an authorized representative will repair or replace the covered item in conformity with this limited warranty. Master Spas authorized service center reserves the right to collect from the original retail purchaser reasonable travel expenses. In addition, access charges will be assessed if the spa is not reasonably assessable for inspection, repair or replacement.

**DISCLAIMERS:** Master Spas neither assumes nor do we authorize any other person to assume for us, any other liability in connection with the sale of spas manufactured by Master Spas. THIS LIMITED WARRANTY SHALL BE THE EXCLUSIVE REMEDY AVAILABLE TO A PURCHASER AND MASTER SPAS SHALL NOT BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES RESULTING FROM MISUSE OF THE SPA OR CAUSED BY ANY DEFECT, FAILURE OR MALFUNCTION OF THE SPA, WHETHER A CLAIM IS BASED UPON WARRANTY, (CONTRACT, NEGLIGENCE OR OTHERWISE. Some jurisdictions do not allow the exclusion of incidental or consequential damages, so this limitation may not apply to you.

To the extent permitted by applicable law, THIS LIMITED WARRANTY SPECIFICALLY EXCLUDES ANY AND ALL IMPLIED WARRANTIES OF (MERCHANTABILITY AND/OR FITNESS FOR A PARTICULAR PURPOSE, OTHERWISE all implied warranties are limited in duration to two (2) years from the original date of retail purchase. THERE ARE NO OTHER WARRANTIES, EITHER EXPRESSED OR IMPLIED, OF ANY KIND OR NATURE WHICH EXTEND BEYOND THE DESCRIPTION OF THE FACE HEREOF.
